- 3. Students must submit a full report ensuring that they addressed all recommendations given by both 1<sup>st</sup> examiner and 2<sup>nd</sup> examiner. This report should be signed by the supervisor of the Thesis.
- 4. Moreover, students must submit the final Thesis within the time period that the student and the panel agreed at the VIVA Examination. Late submissions are not accepted by the programme.
