1. The Chairman, Department Procurement Committee (DPC) on behalf of the BUSL invites sealed bids from eligible bidders for the Procurement of Supply, Installation, and Commissioning of 41 Desktop Computers with Licensed Software to the BUSL.
2. Bidding will be conducted through the Shopping Procedure (Single Stage One Envelope Bidding Procedure) specified in the National Procurement Guidelines 2024 and are called Quotations from all eligible bidders (Registered in Rajarata University of Sri Lanka) as defined in the Guidelines.
3. To be eligible for contract award, the successful bidder shall not have been blacklisted. The qualification criteria for the eligible bidders shall include the following. (Additional qualification requirements are given in the Procurement Documents)
  - a) **General Experiences**
    - i. The Bidder should have at least Three (03) years of experience in supplying, installing, and commissioning of Desktop Computers with Licensed Software.
    - ii. Must operate at least one (01) Maintenance Center owned and managed by the bidder.
    - iii. Average annual Volume of Turnover of the bidder in last Three (03) years' shall not be less than Rs. 12 Million.
  - b) **Specific Experience in contract of similar nature.**

The Bidder should have completed 02 Contracts of supply, installation, and commissioning maintaining of at least 30 Desktop computers or more in each contract during last 03 years supported by reference letters.
4. Late bids will be rejected. Bids will be opened soon after the bid closing in the presence of the bidders' representatives, who choose to attend at 2.30 p.m. on 23.09.2025.
7. All bids must be accompanied by a Bid Security of not less than Sri Lankan Rupees One Hundred Twenty thousand (LKR 120,000.00). The Bid Security shall be submitted in the form of a Bank Guarantee addressed to the Vice Chancellor of BUSL or a Cash Deposit to the Shroff of the University.
8. A Pre-Bid Meeting will be held at 10.30 a.m. on 16.09.2025 in the Senate Room of BUSL. All interested Bidders may participate to the Pre-Bid meeting at their own expenses.
